

PROCEDURE FOLLOWED FOR PROCESSING OF  
APPLICATION FOR CONSENT UNDER WATER AND AIR ACT AND  
AUTHORISATION UNDER THE WASTE RULES.

Common Procedure:

- 1) The industry has to submit an online application on OCMMS.
- 2) The application is then scrutinized by the IT section. The IT section raises query in case the application is found to be incomplete. On receipt of the complete application the IT section release the application for payment of fees. On payment of fees by the industry the application is processed as below.

Consent to Establish/Consent to Operate for Red Category Industries:

- The applications are then marked for inspections to JEE/EA.
- The inspection report is processed from inspection team to AEE. Draft Consents are uploaded if the units are found to be complying or else proposed for issue of directions and processed to AEE (HO) and forwarded to SEE.
- The applications are then forwarded to SEE. The applications are placed before Technical Advisory Committee (TAC). The recommendations are then forwarded to MS.
- MS forwards the application to Chairman for approval, on approval of Chairman Application, the application is approved by the MS (for consent to operate renewal)
- In case of consent to operate (fresh/expansion) the same is placed before the Board of approval.
- Consent is granted by the MS on receipt of approval of the Board.

Consent to Establish/Consent to Operate for Orange Category Industries:

- The applications are then marked for inspections JEE/EA.

- The inspection report is processed from inspection team to AEE. Draft Consents are uploaded if the units are found to be complying or else proposed for issue of directions and processed to AEE(HO)/SEE.
- The applications are then forwarded to Environmental Engineer/MS/Chairman for Approval.
- Consent is granted by the MS on receipt of approval.

Consent to Establish/Consent to Operate for Green Category Industries:

- The applications are then marked for inspections JEE/EA.
- The inspection report is processed from inspection team to AEE. Draft Consents are uploaded if the units are found to be complying.
- The applications are then forwarded to AEE(HO)/SEE/MS/Chairman for approval.

Consent to Establish/Consent to Operate for White Category Industries:

- The applications are the marked for inspections JEE/EA.
- The inspection report is processed from inspection team to AEE. Draft Letters are uploaded if the units are found to be complying and forward to AEE (HO) and SEE for approval.
- The applications are then forwarded to Member Secretary /Chairman for approval.
- Letter is issued for registration under White Category.

Authorisation under Biomedical Waste/ Plastic Waste/Solid Waste/C & D) E-waste/Batteries waste And Hazardous Waste

- The applications are then marked for inspections JEE/EA.
- The inspection report is processed from inspection team to AEE. Draft authorizations are uploaded if the units are found to be complying and forwarded to AEE (HO)/SEE.
- The applications are then forwarded to Member Secretary/Chairman for Approval.
- Authorization are granted by MS.
