

Minutes of the meeting held on 30/09/2016 at 3.00 p.m. in the Conference Hall of Goa State Pollution Control Board regarding Complaints against M/s. Kamleshwar Garage

Mr Marcus Fernandes, complainant submitted as follows;

- 1) M/s Kamleshwar Garage has failed to comply with the directions issued by the Board on numerous occasion. The garage has provided barricading at the side portion of the shed at Canca Road without obtaining the necessary permission from the local body i.e Mapusa Municipal Council. MMC has issued Show Cause Notice to the Garage , dated 27/04/2016 for demolition of the illegally constructed shed in front of the shops .
- 2) The garage continues to carry out operations outside the shed and partly on the road which is in violation of the direction issued by the Board and the shed is constructed in the setback area.
- 3) The garage continues to operate beyond 6 pm especially on Friday which is also in violation of the directions issued by the Board.
- 4) The activity is being carried out in the residential area and is causing inconvenience and nuisance to the Public. The garage is carrying out denting , grinding etc which creates noise and nuisance to the local residents.
- 5) The garage is 15 meters from his residence.

Yuvraj Sitakant Chari, son of the proprietor, Shri Sitakant Chari, stated that , Vinod Vitthal Lokre will represent M/s Kamleshwar Garage,. Shri Vinod Vitthal Lokre submitted as follows;




- 1) The Complainant has accepted that we have provided the barricading in compliance to the directions issued by the Board.
- 2) The Show cause notice issued by the Municipality has not nothing to do with the garage. M/s Kamleshwar Garage has obtained the necessary permissions from the Municipal Council and craves leave to submit the documents in a week.

- 3) The garage operations are stopped at 6 30 pm with lunch hour from 2 to 3.30 pm. The garage commences operation at 9 30 am.
- 4) The Garage started operations in 1975, and in between the operations were suspended somewhere in 1994 because of manpower issues and recommenced operations 2012. When the board had sealed the premises, the garage obtained all the necessary permissions and thereafter the Board has granted Consent to the garage .
- 5) No other residents have filed a complaint with regard to operation of these garage.
- 6) The garage is approximate 150 meters away from the complainant's residence.


