III. Item No. I:-

Confirmation of the minutes of the Tenth Meeting of the Board

The Board considered and confirmed minutes of its Tenth Meeting.

At the time of X th Meeting so me of the members had deputed their sub-ordinate officers instead of attending the meeting personally. Chairman strongly objected to this. He further instructed the Member Secretary to write to all members that they should attend meetings unless for some compelling reasons in which case intimation should be sent in time.

## IV. Item No. 2:-

Follow up action on the decision taken in the X th Meeting of the Board:-

The Board took review of the follow up action taken on the decisions of the X th meeting

(a) The Board observed that the case of M/s. Hindustan Ciba Geigy Limited referred to the Ministry of Environment and Forests seeking clarifications on the effluent standards prescribed under the E.P. Act, 1986 has not been clarified yet. After thorough deliberation it was decided that the expansion proposal of the Company should not be cleared before commissioning of the incinerator and thereby bringing the C.O.D. values of the final effluent to the permissible limit. The Board decided to grant further time to the Company to complete installation of the incinerator so as to complete the same before expiry of their consent order.

(b) While discussing the item pertaining to the list proposed by the Board of small scale industries to be kept outside the purview of pollution control legislation, the Board observed that the list modified by D.I.M. is required to be examined by the Technical Committee. However, the Board suggested that the Government at the first instance may adopt and notify the list of small scale industries consisting of the items common in both the lists i.e. one proposed by the Board and the other by D.I.M. More item could be added to the list so published at a later stage after completion of scrutiny of the other items by the Technical Committee in consultation with a representative of Directorate of Industries and Mines.
