Sealed quotations are invited from reputed/registered service providers for carrying out comprehensive AMC works to the office laboratory and building at Saligao, Bardez Goa.

'Providing day shift electrician and plumber on call for rectifying minor day to day related issues for operation of ETP/STP, pumps, tube well, water pumps and water filtration plant, and other electrical and plumbing items'

The material so required shall be supplied by the Board. However in the event the contractor utilizes, the required material in the event of carrying out minor repairs, a separate bill shall be raised and the same shall be paid as per the MRP/bill raised by the dealer and shall be paid as per actual on approvals. The electrical works shall be excluding maintenance of DG set and lifts.

Terms and Conditions:

1. The Contractors/agencies shall indicate the rates in figures as well as in words correction if any should be duly attested by bidder with date
2. The Contractors/agencies who are interested may inspect the site before quoting for the same.
3. The quoted rates shall be inclusive of service tax and all other taxes as applicable and should be valid for Three months from the date of submission of quote.

4. The last date for submission of quotes is 02/09/2022 at 12 noon Quotations will be opening at 3.00 pm on 02/09/2022 in the office of Goa State Pollution Control Board in the presence of the bidders or their representatives who may like to be present.
5. The contract will be awarded to the bidder whose quotation is determined to be substantially responsive and who has offered the lowest evaluated quotation price.
6. On satisfactory completion of work, final bill duly pre-receipted on revenue stamp along with copy of PAN card shall be submitted by you to the Goa State Pollution Control Board for effecting payment, every month.
7. The quote which is conditional will not be accepted.
8. Necessary tax will be deducted at source.
9. In case of any dispute arising out of the contract with regard to the interpretation meaning or the terms and conditions, the decision of Chairman GSPCB shall be final and binding.
10. The Board reserves right to accept or reject any or all the quotations without assigning any reason thereof.
