4. The last date for submission of quotes is 11/11/2022 at 12 noon Quotations will be opening at 3.00 pm on same day in the office of Goa State Pollution Control Board in the presence of the bidders or their representatives who may like to be present.
5. The contract will be awarded to the bidder whose quotation is determined to be substantially responsive and who has offered the lowest evaluated quotation price.
6. On satisfactory completion of work, final bill duly pre-receipted on revenue stamp along with copy of PAN card shall be submitted by you to the Goa State Pollution Control Board for effecting payment, every month.
7. The agency is required to station one technician/personnel in the Board office from Monday to Saturday. (9.00 am to 6.00 pm)
8. The quote which is conditional will not be accepted.
9. Necessary tax will be deducted at source.
10. The quote shall be exclusive of parts/materials required as the same shall be supplied by GSPCB.
11. In case of any dispute arising out of the contract with regard to the interpretation meaning or the terms and conditions, the decision of Chairman GSPCB shall be final and binding.
