3. The quoted rates shall be inclusive of service tax and all other taxes as applicable and should be valid for Three months from the date of submission of quote.
4. Quotations will be opened at 4:00 p.m. on 25/08/2020 in the office of Goa State Pollution Control Board in the presence of the bidders or their representatives who may like to be present.
5. The contract will be awarded to the bidder whose quotation is determined to be substantially responsive and who has offered the lowest evaluated quotation price.
6. On satisfactory completion of work, final bill duly pre-receipted on revenue stamp along with copy of PAN Card shall be submitted by you to the Goa State Pollution Control Board for effecting payment.
7. The quote which is conditional will not be accepted.
8. Necessary tax will be deducted at source.
9. In case of any dispute arising out of the contract with regard to the interpretation, meaning or the terms and conditions, the decision of Chairman GSPCB shall be final and binding.
10. The Board reserves right to accept or reject any or all the quotations without assigning any reason thereof.
