

Terms of Reference:

1.	The TAC shall discuss and deliberate on those applications received by the Board for the grant of Consent to Establish, Consent to Operate and Authorizations under the Water Act, Air Act and the Rules framed under the Environment Protection Act, 1986 (including renewal applications) from units and establishments, as forwarded to it by the Senior Environmental Engineer of the Board after approval of the Member Secretary and Chairman; and shall thereafter submit its recommendations on the same to the Chairman of the Board through the Member Secretary
2.	The TAC shall meet every Monday at 4.00 pm in the Conference hall of the Board for the above purpose. The TAC shall also meet as and when requested by the Member Convenor on the directions of the Chairman of the Board.
3.	The recommendations of the TAC in the form of minutes, shall be submitted by the Member Convenor of the TAC to the Chairman of the Board through the Member Secretary.
4.	The Committee shall also calculate the penalty to be levied upon defaulting units under the Polluter Pays Principle as and when such cases are referred to it.
5.	The Committee shall also calculate the environmental score in respect of those Industrial units/activities that are not categorized.

All members of the TAC shall be paid sitting fees as per the prevailing Rules in force.

This order shall supersede all earlier orders issued by the Board with regard to the Constitution of the Technical Advisory Committee of the Goa State Pollution Control Board.
