**Terms and conditions of the Quotation/Tender**

1. The quotation/tender should be submitted in sealed envelopes super scribed as "**Quotation for supply of Autoclave for Microbiology Laboratory 2015-16**" due on 10/12/2015 so as to reach this office on or before 10/12/2015 upto 3.30 p.m and will be accepted on behalf of the Member Secretary, Goa State Pollution Control Board. On acceptance of your quotation the ORDER will have to be supplied within one week from the date of receipt of the supply order and delivered at the office of the Goa State Pollution Control Board, Dempo Tower, 1<sup>st</sup> Floor, Patto Plaza, Panaji Goa.

2. Quotation should be filled in ink or typed. The rates filled in pencil shall not be considered. The bidder/agency shall sign the quotation form at each page and at the end in token of acceptance of all the terms and conditions of the Quotation.

3. The rates shall be written in words and figures clearly without any corrections/overwriting.
4. The rates quoted should be inclusive of all taxes, delivery charges, transport, loading, unloading, service tax etc.
5. The rates quoted by the agency should be valid for a period of 1 year from the date of submission of bid/quote.
6. The quotes which are conditional will not be accepted.
7. Goa State Pollution Control Board will not assume any responsibility for loss, fire, damages, thefts etc. of any materials/equipments etc. during the transfer of goods.
8. Attested copy of these terms and conditions duly signed by the agency shall be submitted along with the bid in confirmation of compliance.
9. Overwriting and corrections are not accepted in the quote.
10. The bidder should carefully examine the specifications; work etc. in case of any doubt, the same may be confirmed from the undersigned personally without any delay.
11. The contractor shall not assign or sublet the contract or any part of contract or to any other agencies.
12. The income tax/sales tax will be deducted at source as per the standard practice. Income tax/sales tax liability if any arising in future on account of the said contract will be recovered from the Supplier/Bidder.
13. A copy of income tax/sales tax payment permanent account number/registration number, Service no. should be enclosed.
14. Any other condition imposed by the bidder will not be considered and the conditional quotation will not be accepted.
15. In case of any dispute arising out of the contract with regard to interpretation meaning or the terms and conditions, the place of jurisdiction shall be Panaji-Goa, and the decision of the Member Secretary/Chairman, Goa State Pollution Control Board shall be final and binding.
16. If Agency fails to fulfil the contractual obligation, the work will be got done by the Department at the risk cost of the bidder.
17. The bidder will be responsible for all the legal consequences and liabilities arising out of lapses or negligence on his part (including his material and manpower)
