4. The contract will be awarded to the bidder whose quotation is determined to be substantially responsive and who has offered the lowest evaluated quotation price.
5. Normal warrantee/guarantee/defects liability period shall be applicable to the executed work.

6. On satisfactory completion of work, final bill duly pre-receipted on revenue stamp along with copy of PAN Card shall be submitted by you to the Goa State Pollution Control Board for effecting payment.
7. The quote which is conditional will not be accepted.
8. Necessary tax will be deducted at source.
9. Brochure of the same should be attached /submitted with the quotation.
10. In case of any dispute arising out of the contract with regard to the interpretation, meaning or the terms and conditions, the decision of Chairman GSPCB shall be final and binding.
11. The Board reserves right to accept or reject any or all the quotations without assigning any reason thereof.
