#### **AGENDA ITEM NO. 2**

FOLLOW UP ACTION ON THE MINUTES OF THE 44<sup>th</sup> MEETING OF THE GOA STATE POLLUTION CONTROL BOARD

The Member Secretary briefed the members about the further development on the Implementation of the Bio-medical Waste (Management and Handling) Rules, 1988 and the Re-cycled Plastic Manufacture and Usage Rules, 1999. The members opined that the major hospitals should establish bio-medical waste management system on priority to streamline collection of the waste. Member Secretary explained the importance of common disposal sites to minimise number of incinerators for incineration of bio-medical waste.

The members were informed that the Chairman will take up both these issues to Hon. Health Minister.

VISIT TO META STRIPS LTD., SANCOALE.

After completion of the deliberation on the agenda items in the office, the members visited the production plant of Meta Strips Ltd. at Sancoale Goa. Shri Saxena, Vice -President, Technical, alongwith other officials of the company explained the production process with the help of flow diagrams. Thereafter the members inspected various production units of the plant.

The company authorities were advised to maintain a documentary record of the impurities in every batch of the raw material and those in the final product produced from that batch of the raw material. The company authorities mentioned that they are in the process of installing reverse osmosis plant to achieve total re-circulation of the effluent. Till such time, the effluent before discharging will be analysed in the presence of the Board Scientist.
