2	Identification of sites for collection and processing facility	a) Goa Waste Management Corporation (GWMC) is in process of setting up C&D Waste Management Facility of 500 TPD capacity in survey no. 146/2, 146/3, 146/4, 146/6, 148/2, 148/6 & 148/7 of Village Curchirem of Bicholim Taluka. GWMC has floated tender for fencing and security-cabin at the said site, the tender has been finalized and work order will be issued post demarcation. GWMC is awaiting Demarcation from Dy. Collector- Bicholim. The Board has granted authorization to GWMC for temporary storage of C&D waste (inert) at the said site. Meanwhile GWMC has also initiated process for identifying an alternate land for C&D facility. b) Meantime, Collector North Goa has notified an abandoned laterite quarry in Tuem Village for deposition C&D waste for backfilling and subsequently deposition of waste by various departments has already started. Since commencement upto 31/03/2023 approx. 2000 cubic meter of C&D waste has been backfilled in abandoned quarry at Tuem. The Board has granted authorization to The Director of Mines & Geology, Panaji for backfilling of abandoned laterite stone quarry with C & D Waste (inert) in Sy. No. 119/6 to 119/18 & 119/35 to 119/37 of Village Tuem, Pernem Goa.
