This Environmental Public Hearing (EPH) is conducted as per the revised EIA Notification dated 14/09/2006 (as amended) issued by the Ministry of Environment, Forest and Climate Change, Government of India.

Shri. Kedar A. Naik, Additional Collector-II, North Goa and Dr. Shamila Monteiro, Member Secretary of the Goa State Pollution Control Board presided over the hearing.

The hearing commenced at 10.30.A.M. so as to enable the public present to complete formalities of registration as speakers.

The local Authorities such as Village Panchayats and Municipalities were requested to give vide publicity of the Public Hearing within their Jurisdiction. Poster/banners were pasted at prominent places and Public were informed through public address system. Thus, enough publicity was given.

The people of the villages will get affected by cancer in future. Previously there were less mechanism, hence people were getting a lot of employment and now there are many machines used hence less people will be employed. The Regional Plan shows no mining zone, he questions how mining is considered in this area. He states that there is pond which is also not mentioned. He sought to know whether there was any permission given to divert the mullah from the survey plan. He stated that in 2006 the mullah was diverted and agricultural activities were stopped. If there was no permission granted than why action was not taken till date.

89. ANANT GHAD, ADVALPALE

He strongly objects the operation of the mining unit.

This mine was in operations from 1952. And the report states it is new mine . the report is false. The mining operations were denied permission. He requested in writing to the authorities to cancel/postpone the public hearing including The Member Secretary, GSPCB, District Collector.

The gram Sabha of Advalpale Panchayat deliberated at length and resolved unanimously during ikts meeting held on 29/10/2023 rejecting their application for Gram Sabha consent and NOC for commencement of mining operation allied activities at Advalpale until past destruction of agriculture, water resources and environment are rectified.

The TOR was granted on 14-11-2023, while the block was awarded on 12-07-2023. The study could not have been carried out in March – May 2023 before the TOR was granted and hence the study is completely false and Fabricated.

Non of the facts on the ground are recorded. The houses of people within the adjoining block areas are not considered. There are about 25 houses, 2 worship places and a crematorium within the lease area. However the draft EIA states that there is no need for any rehabilitation.

The adverse impacts of mining on the local communities are not considered. There are no socio economic data or studies in the draft EIA report.

The list of flora and fauna is falsely provided. The actual number reaches over 1000 species and 700 species and not just 110 or 230...

He states that there are many shetkari s/agriculturist in the village, the EIA report states there are no shetkari's present. He states that the report of the Ground water is totally false.

He states that the consultant who prepared the EIA report for all three blocks was the same. And the EIA report is copy and paste from earlier EIA report of other mine leases. The EIA report has not taken the actual fact into account.

He states that the worship places are not taken into account and no villagers views are taken into account , no person had come to survey the area before preparing the EIA report.

The EIA report is False and Fabricated. He states that the Government has to study and verify the ground reality before granting the lease.

90. ABHIJIT PRABHUDESSAI, MARGAO

He states that he is from Margao Goa.

He states that EIA study states that the baseline data was collected from March to May 2023. He stated that this is well before the lease was granted, hence is illegal. He stated that the study also states that on page 271 under "Disclosure of Consultants" that almost all the experts finished their work by June 2023, much before that letter of intent was issued.

He stated that all the work for EIA study is therefore without any rights on the lands to be studied, amounting to trespass and authorised work.

He stated that before preparing of EIA the Consultant never visited the place. He stated that as follows:

- a. Disastrous drop of Groundwater table.
- b. Cumulative and aggravating threats due to adjoining mines
- c. Distraction of major nallah within the lease area.
- d. Loss of agriculture

He further stated that TOR be revoked since TOR compliance misguides the authorities by falsely stating in response to the first TOR condition asking for year wise production details since 1994, that the Block V is a fresh lease and year wise production since 1994, is therefore not applicable.

He stated that the jetty at Sirsaim is illegal and has no permission from GCZMA, as it is shown on the approved CZMP 2011.

He stated that EIA Report nowhere refers to the guidelines manual prepared by the Ministry of Environment, forest and Climate Change . None of the guidelines laid down are followed.

He states that he has strong objection to fraudulent EIA study and TOR by M/s Fomento Resources Private Limited for Block No. V- AdvalpaleThivim Mineral Block with area of 36.2202 HA.

He states that the data submitted of Flora and Fauna is completely false and outrageous. He further states that the data of flora and fauna within the core area is also outrageous. He stated that there are 100 of species trees, including fish-tail palm, kindal, matti, Jackfruit, Cashew, Mango and numerous forestry species within the core area, but only 4 are listed. There are dozens of species of mammals within the core area, but only 3 are listed. Grant of lease is without application of mine.

He further requested google earth and regional plan RP 2021 images clearly shows that major settlement area included within lease area though the block V created only recently.

He states that the Government of Goa is completly failed/ ignored the observation of the judgement of supreme court, the government is required to study first environment destruction and its adverse impact upon the local communities.

He raised the strong objection stating it is unlawful of the authorities to ask him to stop speaking in view of time restriction as there is no such law in place.

He submitted the written submission.


