Proceedings of the Environmental Public Hearing held on 18/10/2024 at 10.00

The accordance with the Environmental Impact Assessment 2006; in respect Block VII Cudnem Mineral Block with area 75.3004 Ha Located in Cudnem Village in Bicholim Taluka and Sonus Vonvoliem and Onda village in Sattari Taluka, North Goa District, for the production of 0.5 MTPA of Iron Ore by M/s. Vedanta Limited."

This Environmental Public Hearing (EPH) is conducted as per the revised EIA Notification dated 14/09/2006 (as amended) issued by the Ministry of Environment, Forest and Climate Change, Government of India.

Shri. Mahadev Araundekar, Add. Collector I, North Goa and Dr. Shamila Monteiro, Member Secretary of the Goa State Pollution Control Board presided over the hearing.

The hearing commenced at 10.00.A.M. so as to enable the public present to complete formalities of registration as speakers.

At the outset, the Member Secretary of the Goa State Pollution Control Board welcomed the public present for the Public Hearing and explained the procedure to be followed during the Environmental Public Hearing.

The public present was requested to express their views/objections/suggestions if any, after the Project Proponent gave its presentation on the proposed project.

It was informed that the views/objections/suggestions made by the public during the hearing would be recorded and forwarded to the Concerned Authority

for processing and requisite action on application regarding environmental clearance for the proposed project.

The Representatives of the Project Proponent have thereafter made a Power Point presentation concerning the project by explaining the contents thereof in Konkani.

The Member Secretary of the Goa State Pollution Control Board thereafter invited the public present at the Public Hearing to come forward and submit their views on the project.

The Member Secretary of the Goa State Pollution Control Board requested the speakers to try to restrict their submissions to 5 minutes each. He stated that speakers will be called upon to speak sequence wise.

He requested that a roundabout should be built near the Power station. He requested that the temples should be preserved. He stated that the youth from the village should be given employment. He submitted that he is thankful that there was development in the village and requested that the percentage of the CSR funds utilised towards this should be increased.



Hence he requests to conduct the survey of the villages once again. He stated that there are 10 types of creepers, out of which only 4 are mentioned in the draft EIA report. He states that there were natural resources which have not been mentioned, he states that the fields were not shown in the EIA draft. He fears that the fields will be damaged. He states that the nullahs, the water table details were not mentioned in the EIA draft. He once again request to re carryout the survey in the surla village since it is 2.5 km away from the block VII. He states that he supports the operation of the Block VII -Cudnem Mineral Block to be operated by M/s. Vedanta Ltd.



He states that he fully supports to the mining project Block VII-Cudnem Mineral Block, Bicholim and Sattari Taluka.

He states that during the Covid times Vedanta supported the villages by providing the villagers with food and necessary items and also constructed Anganwadies, when the mines were stopped the people were affected as water supply stopped and the educations facilities were affected, the youth were unemployed. Hence, he pleads the Government to start all the remaining mining



blocks as soon as possible.

51. NARAYAN M. GAWANDE

He stated that there are a lot of fields, farms in the locality and no proper survey is provided. He requested for a resurvey to verify the same. He stated that the natural nallah mentioned in the EIA is wrongly mentioned as seasonal nallah and the same should be rectified. He stated that jobs should be granted to local youth. He requested that the houses and farmers affected by mining should be compensated. He accused M/s. Vedanta to be a liar. He submitted that for the past 15 years there is no water supply in the village.

SAJON WADKAR

He states that he is the Zilla Member. He states that he worked in the company for 32 years. He states that earlier the company's name was Sesa and now Vedanta. He states that he supports mining, but when it comes to agriculture around 90 acres of land, has been destroyed due to mining. He states that around 58 agriculturists have suffered, they must be compensated. He states that once mining resumes, it must be ensured that the people are protected and looked after. He states that if we go to meet any of the employee's of Vedanta, they don't know us, this should not happen. He states that the company Vedanta must ensure welfare of the people and the village. He states that mining should resume or else the situation will get worse.

He states that everyone wants that the mining operations resume and

He states that if the beneficiation takes place in Cudnem then the tailing pond water shall be discharged into the nullah which has to be checked by the GSPCB so that the silt water is not discharged into the nallah. As previously the tailing water was directly let out in the Mandovi river by the Fomento mines. He states that de-silting has to be conducted frequently and there should be monitoring done of the tailing pond. He states that the jetties which belong to the private owners and the private owners don't allow the new mining owners to use their jetty for loading and unloading activity. He requests the government of Goa to pass a legislation to use the nearby jetties of the private owners as the shortest route for transportation as the same will control the pollution and will minimize the damage to the environment.

He states that he fully supports the mining project Block VII-Cudnem Mineral Block, Bicholim and Sattari Taluka. He stated that he is thankful to the Chief Minister of Goa for initiating steps towards resumption of mining as per Supreme Court Guidelines. He submitted that he is the Resident of All Goa Machineries Owners Association. He requested that the use of Goan owned machinery should be given preference. He submitted that he had participated in lot of protest and

also was lathi charged and he is happy that the mines are resuming. He stated that the tender of machinery is granted to an outsider. The Government should try to grant opportunities to local machinery owners. He also submitted that the fields in the locality should be preserved.

58. SANDANAND U. MALIK

He states that he is the resident of Cudnem. He states that he is the former MLA & Minister. He states that he heard all speakers and as he was the Minister, he understands the people's difficulties. He states that there was a committee set up to look after the problems and he was the member of that committee. He states that there was negligence on the part of the authorities as far as my village is concerned. He states that his village is heritage village. He states that his village is an eco-sensitive village. He states that for the last 12 years Government never did anything to repair the damage. He states that Communidade land is a village republic. He states that entire village Cudnem is private village governed under the Goenkary form of governance and Goenkar are absolute owners of entire village and does not vest in the Government. Therefore the government has no jurisdiction to allow mining activity in the Village without consent of Communidade. As per available record of the year 1852, 1856, holders of land still continue to pay foro to Communidade evidencing that they hold the land. Further, the Government of Goa has brought in circulation the record of right giving occupancy rights to these holders of land in this village when such records of rights can be brought in circulation for the grants made by the Government for Government

land. Therefore, the records of Rights are fake and fraudulently created. The land in Goa does not vest in Central Government under any statute so Goa cannot be said to be a revenue district to be headed by the District Collector.

He states that he had served 2 notices to the Department of Mines on 17/08/2014 and in 2018 to the Union Government, asking for Director of Mines that the Government does not have the right over the land and only Communidade are the grantor of land. He states that when legal notice is issued no response was received by him. He questioned the further course of action He states that Government of India and Goa are on different footings about the land.

He states that after abolition of property of Daman and Diu was passed, Collector post came into force. He stated that in 1965 Judgement given by Supreme Court said that in Goa most of the land are under Communidade and they are the grantors. He stated that even the position of Collector is questionable in Goa and that Goa Land Revenue code, 1968 came into force to accommodate the post. He states that from 1962 royalty and fund must be provided. He states that there is misuse of power by the government. He states that Cudnem is a heritage. He states that he is not in favour of leasing of land by the Government to the Company. He states that he is not supporting leases given by the Government.

UDAY NATEKAR 59.

He states that the GSPCB is fully responsible for the damages / pollution done to the environment by the operation of the mines. He states that the draft EIA notification is falsely prepared and he stated

that he wants the definition and clarification on the word "Seasonal Nallahs". He states that the consultant who has prepared the draft EIA report has to be present during the Public Hearing. He stated that the questions were not answered by the Authorities present on the Dias. He questions the Company as to why the previous employees were sacked out and payments not continued. He states that when Dempo were operating the mines there were no adverse effects of the mining activities on the villages and when Vedanta took over the mining activities stopped. Because of mining activities conducted by Vedanta company has affected the agricultural activities. He states that the golden temple, Kandil flower which lies in the Surla village is not mentioned in the Draft EIA notification.

Previously when Fomento and Sesa was operating there was water supply continuously and sought to know why the water provided and other facilities stopped when the mines were closed. He questioned in such cases how he can support the mining activities. He states that both the DMG and GSPCB are responsible for pollution. He states that when Dempo were operating the mines there were no adverse effects of the mining activities on the villages and when Vedanta took over the mining activities.

He states that there was clear water in the wells previously and now because of mining activities it has become turbid. He states that

There is no hydro geological study carried out. He states that the Panchayat has provided the copy of the draft EIA notification just before 2 days, hence it becomes difficult to study the report. He states

that no farmers were taken into consideration while preparing the draft EIA notification. He states that people have diverted to the agricultural activities during the mining ban, however once the resumption of the mines it may again affect the agricultural activity and will again make the villagers dependent on the mining activities. He states that he will challenge the report if no clarification is provided to the questions raised by him. He states that the fields, agricultural lands and other sites are not considered while preparing the draft EIA notification. He states that the GSPCB has to study the draft EIA notification and check if it is correctly prepared. He states that that mining ban was due to the GSPCB

He states that he objects the operation of the Block VII -Cudnem Mineral Block to be operated by M/s. Vedanta Ltd. He states that till the previous grievances of the villagers are not solved he will not allow the resumption of this project.

60. BUDHO KHODGINKAR

He is resident of Surla. He stated that he resides within 1 km from the mine. He stated that there were so many mining companies in the village but after mining stopped, none of them helped the locals. He stated that there are no schools and colleges in the village. He stated that the students had to suffer from dust pollution. He also objects to the mention of seasonal nallah in the EIA. He agrees with the submissions made by Uday Natekar. He stated that the EIA report is fake. He stated that the Police do not entertain the complaints about dust pollution. He stated that the fields are barren and filled with silt.

He stated that he has no objection for the mine to resume, however the Government should conduct a proper survey.

He states that he is the resident of Dignem. He states that mine is situated behind his house around 2 minutes away. He states he has no objection for resumption of mining. He states that the working of mining is not known by him. He states that the road which joins the mining is accident prone. He states that safety of the locals must be first taken into consideration. He states that if business activities start, it will help in economy generation. He states that there are 4 to 5 houses near the mines which must be protected. He states that the locals must be given first preference for employment.

He stated he is a resident of Cudnem. He stated that he is a teacher. He stated that as per the EIA mining will be carried on for 20 years. He stated that there is no mention about environment. He stated that there no mentioned of heritage sites, temples, in the locality. He stated that people should not thank and appraise Vedanta for the development and other facilities as it is a give and take business. He stated that the Government should implement proper clause for the mining process. He stated that he submitted mining is required but also sought to know what will happen after the 20 years lease is expired. He sought to know what are the ways that the company will preserve the heritage sites, temples etc. He sought to know what will happen to farmers after the mine resumes. He stated that he has suffered a loss of lakhs

of rupees. He stated that it is very difficult to approach the company with any grievance as the Head office is located far away. He submitted a detailed written submission.

He states that he is in support of Block-VII-Cudnem Mineral Block of Vedanta Ltd. He states that once mining resumes, benefits will be many, various businesses will flourish, economy will grow. He states that before the rate of interest to get loan was low, but now the same has been increased. He states that this block should start as early as possible. He states that profits of the company must be used for the welfare of the people. He states that mines are located in their area and facilities like educational institutions, etc are constructed in other areas. He states that benefits and facilities must be provided in their villages. He states that mining company must provide support to the villagers specially the youth who are well educated. He states that environment and other resources must be protected, only then they will support mining. He states that economic benefits must be given to the villages. He states that funds should be utilised for the benefits of the locals. He states that Maushi Panchayat, Mollem Panchayat too comes under the aerial distance of mining and these villages must also get benefit from these mining.

He also seeks clarification on para 4.7.2 regarding the ground water table and major pumping of water from the mining pit. He seeks clarification w.r.t. para 4.8.5 regarding wetland areas. He states that there will be Impacts on the wet lands, water pollution degradation of land flora and fauna, the bird migration, reduction of wild growing plant, effects the pollution in the buffer zone. He states that the Cudnem river was adversely polluted and there were major health effect, skin diseases due to dust pollution, agricultural land was polluted. He states that the company requires 95000lts / day of water. He questions how we can afford to supply the water. The rivers are full of Silt. Hence, he states that there is an increasing level of danger to humans. He states that Human Impact Assessment is not done. He states that he objects to the operation of the Block VII -Cudnem Mineral Block to be operated by M/s. Vedanta Ltd.

78. MAHENDRA N. EKAWADE

He stated that he is speaking in behalf of the villagers of Cudnem. He stated that for the last many years the villagers are depended on mining. Clarification regarding the seasonal Nallaha given by Project Proponent.

With regard to the Publicity of the Environmental Public Hearing, the Presiding Officer informed that the GSPCB has issued public notices in the newspapers namely; The Goan Everyday (English), Gomantak (Marathi), Bhangar Bhuim (Konkani), The Free Press Journal, Mumbai (English) informing the general public regarding the date, time, venue, submissions of objections, suggestions, suggestions, placement of EIA reports for reference, etc. The GSPCB has also issued advertisements on local Television/radio channels continuously for 3 days informing general public of the Public Hearing. The local Authorities such as Village Panchayats and Municipalities were requested to give vide publicity of the Public Hearing within their Jurisdiction. Poster/banners were pasted at prominent places and Public were informed through public address system. Thus, enough publicity was given.
