

Service Name: Authorization under Bio-Medical Waste Management Rules, 2016

Bio-medical waste is any waste that is generated during the diagnosis, treatment, or immunization of human beings or animals. The BMW Management Rules apply to all establishment which generate, collect, receive, store, transport, treat, dispose, or handle bio-medical waste in any form. In Goa, the Goa State Pollution Control Board (GSPCB) is the authority responsible for enforcing the BMW Management Rules and issues authorization. The authorization will specify the activity for which it is granted, conditions for compliance, and the validity period.

The Board in its 132nd meeting held on 27/03/2018 approved the processing fees Authorization under Bio-medical Waste Management Rules, 2016 as follows:

The Health Care Facilities (HCF's) obtain Authorization under the Bio-medical Waste Management & Handling Rules, 1998. The fees for which are notified in Official Gazette dated 21/08/2014. The new rules have not explicitly provided for levy of fees to the health care facilities in respect of application submitted for grant of authorization under the

The Board is an autonomous body and is funded through the fees submitted by the proponents. In view of the expenses incurred by the Board, it is required to charge processing fees to the HCFs for their application.

CIRCULAR FOR ONE TIME AUTHORIZATION

The Board at its 132nd meeting held on 27/03/2018 and 133rd meeting held on 29/06/2018, has approved for amending of fees for authorizations issued by the Board under Biomedical Waste Management Rules, 2016 for which Board charged fees of Rs. 1,000/- per annum for non bedded health care facility with maximum validity for the period of 10 years and issued Circular vide Order No.13/1/18/13-PCB/Vol.X/Tech/13509 dated 22/10/2018. The same was notified by The Department of Environment by the Official Gazette Notification dated 02/06/2022.

Wherein Board was in receipt of representation dated 10/07/2023 and 30/08/2023 from Goa Private Dental Practitioners Association, requesting for exemption in the authorization fees and one time authorization for non bedded facilities and the same was placed before 156th meeting of the Board which was held on 12/09/2023

The Board at its 156th meeting held on 12/09/2023 has approved for grant/issue of one-time authorization of the Board under Biomedical Waste Management Rules, 2016 to non bedded health care facilities. The administrative charges towards the same shall be Rs. 15,000/-(Rupees Fifteen Thousand only), subject to the condition that there is no change in name of the Occupier, location address of the facility and quantities/category of waste generated by the health care facility.

In furtherance of the notification No.3/02/2015-IND/64 dated 25/01/2021issued by the Department of Industries, Government of Goa, the Goa Investment Promotion and Facilitation Board (Goa-IPB), State's implementation agency for Ease of Doing Business, hereby issues the following mandates as outlined below:-

- 1) Further to point 3 of the above mentioned notification, the online system for Public Consultation has been implemented in the State to ensure the following for all proposed regulations in the State:
 - i. Legal basis
 - ii. Necessity
 - iii. Business friendly policies
 - iv. The drafts of proposed acts, rules or regulations should be made available for a minimum period of 30 days

All departments of the State Government are to note the above four points while drafting and proposing any legislation, rules or regulations.

- 2) Furthermore, the online single window system and all online services should have the following features:
 - i. End-to-end online application and submission
 - ii. Online payment and document submission
 - iii. Online status tracking and department comments
 - iv. Online certificate issuance and download
 - v. Facility for online verification of certificates/ licenses/ permits by third parties

All Departments of the State Government and their IT vendors concerned should make sure that any service made online should have above mentioned features for the online systems used and developed by them.
