The Board at its 122<sup>nd</sup> meeting held on 28<sup>th</sup> November, 2016, had approved for amending of fees for authorisations issued by the Board under (a) Hazardous Waste Authorisation (b) E- waste authorisation (c) Amendments and expansion involving no additional investment (d) for registration of dealers under Batteries Waste (Management and Handling) Rules, as under:

a.	Hazardous Waste Authorisation	Rs. 10,000/- for issue of such authorisation
b.	E-Waste Authorisation	Rs. 10,000/- for issue of such authorisation
c.	Batteries Waste Authorisation	Rs. 10,000/- for issue of such authorisation
d.	Plastic Waste Registration	Fresh registration with validity of one year – Rs. 3000/- and subsequent renewal registration Rs. 10,000/-
e.	Municipal Solid waste Authorisation	Rs. 10,000/- for issue of such authorisation

Further, a penalty of 50% shall be imposed on Authorisation / Registration fees payable, if the application is not submitted by the date, as prescribed under the concerned Rules for the purpose of renewal.

#### **MEMORANDUM**

In furtherance of the notification No.3/02/2015-IND/64 dated 25/01/2021issued by the Department of Industries, Government of Goa, the Goa Investment Promotion and Facilitation Board (Goa-IPB), State's implementation agency for Ease of Doing Business, hereby issues the following mandates as outlined below:-

- 1) Further to point 3 of the above mentioned notification, the online system for Public Consultation has been implemented in the State to ensure the following for all proposed regulations in the State:
  - i. Legal basis
  - ii. Necessity
  - iii. Business friendly policies
  - The drafts of proposed acts, rules or regulations should be made available for a minimum period of 30 days

All departments of the State Government are to note the above four points while drafting and proposing any legislation, rules or regulations.

- 2) Furthermore, the online single window system and all online services should have the following features:
  - i. End-to-end online application and submission
  - ii. Online payment and document submission
  - iii. Online status tracking and department comments
  - iv. Online certificate issuance and download
  - Facility for online verification of certificates/ licenses/ permits by third parties

All Departments of the State Government and their IT vendors concerned should make sure that any service made online should have above mentioned features for the online systems used and developed by them.
