MINIMUM ELIGIBILITY CRITERIA FOR BIDDERS

The online application should accompany the following documents (Scan and Upload on the e-Tender

website):

- a. Attested copy of valid Registration Certificate.
- b. Attested copy of PAN Card
- c. Attested copy of Goods & Service Tax Identification Number (GSTIN) issued by Sales Tax Department.

TECHNICAL CRITERIA :

The bidder should have valid registration for e-Tendering with GSPCB.

The attested copies of original work/Supply orders to and certificates issued should be submitted online along with the bid.

NOTE : All the documents should be attested by Government Gazetted Officer or duly notarized.

MODE OF SUBMISSION OF E.M.D. WITH THE e-TENDER DOCUMENTS:

- A. The bidders can deposit the full EMD of Rs. 5,00,000.00 as per the tender amount on or before the closing date and time of submission of tenders through online **Mode of Payment towards Tender Document Fee (TDF), Tender processing Fee(TPF) & Earnest Money Deposit (EMD) to be paid online through e-Payment mode via:**
 - i. **National Electronic Fund Transfer (NEFT)/ Real-Time Gross Settlement (RTGS). Tenderer should download pre-printed Challan available on e-tender website and make its payment through any of their Bank.**
 - ii. **Net Banking: Payment can be made through the Internet Banking of any Bank.**

Note: Any payments made through NEFT/RTGS will take 24 hours for its reconciliation. Hence the payments through NEFT/RTGS should be made at least TWO BANK WORKING DAYS in advance before any due date and the scanned copy of the challans should be uploaded in the e-Tender website as a token of payment.
