2.	Quotation should be filled in ink or typed. The rates filled in <u>pencil shall</u> not be considered. The bidder / agency shall sign the Quotation form at each page and at the end in token of acceptance of all the terms and conditions of the Quotation.					
3.	The rate shall be written in words and figures clearly. Corrections <u>if any</u> , should be duly attested by the bidder with date.					
4.	The rates quoted should be inclusive of all i.e transport, loading, unloading service tax etc.					
5.	The rate quoted by the agency should be valid for a period of One year from the date of submission of bid/ quote.					
6.	The quotes which are conditional will not be accepted.
